1. Establish and manage the pre-contractual, contractual and post-contractual relationship of a commercial, civil or labor nature and any other relationship that arises between the parties by virtue of the fulfillment of a legal or contractual obligation by COLANTA.
2. Consult, verify and confirm the personal data that the Owner provides by crossing them with public databases, National and International control lists related to money laundering and financing of terrorism, illicit activities or situations regulated by the criminal code. Colombian, to comply with the SARLAFT regulations applicable to the Cooperative.
3. Transmit the personal data of the Owners to control, judicial or administrative entities, when these are required or necessary for the fulfillment of their functions.
4. Transmit the Owner's personal data to Third Parties, even outside the country, with whom it makes alliances or contracts for administrative, commercial and operational purposes included within its corporate purpose.
5. Share personal data with commercial allies, to offer services that may be of interest to the Owner.

10. Carry out analysis, studies and/or research for statistical purposes for making corporate, strategic or commercial decisions..
11. Consult and process personal data to carry out evaluations and/or monitor the quality of the product received or delivered that allow decisions to be made.
12. Send through any means of communication, electronic or physical, known or to be known, information and notifications of a general, institutional, commercial and/or marketing nature, related to the products and services offered by COLANTA or any of its brands, business units and/or associated commercial establishments, as well as their subsidiary, subordinate or controlled entities, as well as any in which COLANTA has an equity interest.
13. Inform, offer and execute corporate, educational, recreational or commercial programs or events developed by the different areas of the COLANTA Cooperative or by allied third parties.
14. Present, communicate and offer products and services of agroindustrial consultancy and/or technical assistance that are provided by COLANTA and by allied third parties.
15. Conduct satisfaction surveys and marketing studies of the services provided and products offered by COLANTA.
16. Respond to queries and complaints in the exercise of the right of habeas data that are made through the channels that COLANTA makes available to the Holders.
17. Present, communicate and offer products and services of agroindustrial consultancy and/or technical assistance that are provided by COLANTA and by allied third parties.
18. Obtain, compare, evaluate and consult by Colanta or whoever represents your rights, despite in the future the status of creditor in the information centers of the Financial Superintendence of Colombia, Datacrédito or any other source, the relative information and references to their credit behavior and debt capacity.
19. Report to the information centers of the Financial Superintendency of Colombia, Datacrédito or any other source, the information related to compliance or non-compliance with your credit obligations, in accordance with the provisions of Law 1266 of 2008 and 2157 of 2021 and advance all the procedures required to carry out the collection of obligations and the recovery of portfolio both judicially and extrajudicially

Treatment of sensitive data.

Rights of the owners of the information.
